

# FOR APAC International Austrian–EU Summer School 2026

## Terms and conditions

### Agreement with the University of Salzburg

These terms and conditions govern the relationship between you (the applicant) and the University of Salzburg with regard to your application and participation in our summer course programme and form part of the contract. By registering via the online form, the offer is considered to be booked and subject to a fee. The right to participate only exists after full payment of the tuition fees.

### Tuition fees

The fee for participating in the Summer School is:

- EUR 4,588.00

**Included services:** This fee covers accommodation (including breakfast), all transfers within Europe that are part of the official programme lecture fees and excursions (including entrance fees).

**Insurance notice:** The fee includes travel medical insurance only. There is no liability insurance or any other form of insurance provided. Participants are expressly required to arrange any additional insurance coverage (e.g., personal liability) at their own expense.

Please consult your bank regarding transfer fees. You must ensure that the full amount is received by the University of Salzburg without any deductions.

### Cancellation period

If you wish to cancel your participation, you must notify us via e-mail including a brief explanation. The following refund schedule applies:

- **Cancellations after 15 April and before 1 May 2026:** 75% refund of the tuition fee (minus bank transfer fees)
- **Cancellations between 1 May and 31 May 2026:** 50% refund of the tuition fee (minus bank transfer fees).
- **Cancellations after 31 May 2026:** No refund of the tuition fee will be issued.

### Delivery of the programme

The University of Salzburg reserves the right to cancel or significantly alter the programme under exceptional circumstances, including but not limited to:

- If there are not enough applicants registered for the Summer School.
- If an event outside of our reasonable control prevents us from running the Summer School or the course. Force majeure.

In the event of full cancellation by University of Salzburg, the tuition fee will be refunded. If the programme is only partially carried out, the fee will be refunded on a pro-rata basis.

## Your responsibilities

By accepting the conditions, you agree to:

- Punctuality: Attend all lectures, excursions, visits, and transfers on time. Attendance is recorded daily.
- Mandatory Attendance: You must attend ALL CLASSES to qualify for an attendance certificate and ECTS credits (5 ECTS) (apart from sick leave). The following events are also mandatory: Introduction, Final Discussion, Exams.
- Absences: If you are unable to attend due to illness, you must inform us immediately via e-mail, WeChat/WhatsApp, or in person. Absence for health reasons is only excused if a credible reason or medical certificate is provided.

## Intellectual property & recording

All materials provided by the Summer School and any associated intellectual property rights remain the property of the University of Salzburg or the respective lecturers. Recording or filming lectures is strictly prohibited without the express prior permission of the lecturer.

## Governing law and jurisdiction

This contract, as well as any tort claims arising from it, shall be governed exclusively by Austrian law. The courts of the city of Salzburg shall have exclusive jurisdiction over any disputes. Subject-matter jurisdiction is determined by the rules of domestic Austrian jurisdiction.

## Limitation of liability

The University of Salzburg or FOR APAC will not be held responsible for failure to execute obligations specified herein directly or indirectly occasioned by or through or in consequence of war, change of statutes of the Austrian Government, strikes, riots and acts of God or conditions beyond the control of the University of Salzburg or FOR APAC.

## Rules of conduct

Participants are expected to behave with the same level of responsibility as at their home institution. In the event of a violation of ethical standards or the rules of the University of Salzburg, the University of Salzburg and FOR APAC reserve the right to impose sanctions, which may include dismissal from the programme.

## Severability clause

Should individual provisions of these General Terms and Conditions be wholly or partially invalid or unenforceable, this shall not affect the validity of the remaining provisions. The invalid or unenforceable provision shall be replaced – to the extent permitted by law – by the statutory provision that comes closest to the economic purpose of the invalid provision.
